#### E. NEW BUSINESS.

#### 1. School District Reports.

Interim Director of Blount County Schools Jake Jones thanked the attendees for their presence, and Lanier Elementary School for hosting. He mentioned Lanier being a legacy K-12 school for over 100 years! Principal Connie Lotter was introduced to give a presentation about Lanier Elementary School.

Mr. Jones spoke about the BCS Spotlights brochure that included recognizing students that scored 30 or above on the ACT; Counselor Appreciation week; Career & Technical Education (CTE) month; tenured teachers; and the One Book Blitz that all three school systems participate in. He introduced Dr. Alisa Teffeteller as the next interim director of schools.

Supervisor of Facilities, Maintenance and Capital Projects James Duke reported on various on-going projects across the school system, that included: renovation of William Blount (WB) CTE, roofing projects for Friendsville gym and WBHS, Carpenters Middle fire alarm system upgrade, HVAC controls upgrade at Union Grove Middle and Heritage Middle, WB's softball concession stand, HVAC replacement at WB Ninth Grade Academy, tracks at Heritage High and WB. Mr. Duke also mentioned a budget increase request for contingency funding of 177 projects.

There was no action taken.

## 2. Blount County School Board.

The Chair inquired about the Ex Officio School Members vacancy on the Education Committee since Fred Goins resigned from the BCS Board of Education.

School Board Member John Lowe talked about the various school audits; and preparations for the upcoming 25-26 budget.

The Chair inquired about the Board of Commissioners recognizing this year's Seniors who scored a 30 or above on the ACT. A motion was made by Commissioner Akard, that was seconded by Commissioner Davis, for the item to be on the April 2025 Commission agenda. A voice vote was taken with all voting aye, and none were opposed. The Chair declared the motion to have passed. The Chair will follow-up with the Clerk about this item.
