BE IT REMEMBERED, that a Blount County Beer Board meeting was held on Thursday, October 9, 2025, at 5:30 p.m. in the Blount County Courthouse of Maryville, Tennessee. Blount County Beer Board Vice Chair Misty Davis called the meeting to order. An electronic roll call was taken by Blount County Clerk Chief of Staff Brad Bryant. There was 1 member present and 8 absent. The Chair declared that a quorum was not present. The Chair recognized the Clerk, to read the call out loud. Beer Board Attorney Scott Stuart was recognized to open the public hearing. Attorney Stuart administered the oath to the applicant, Patrick Clancy. Mr. Clancy affirmed to be the business owner of Route 129 Smokehouse, and that all the information in the application, including all supporting documentation and statistical data, to be true and correct to the best of his knowledge and belief. The request under consideration for a bar-b-que sit-down restaurant located at 106 Calderwood Highway, Maryville, TN 37801. The property owner of the establishment being David Tex Hill. Mr. Clancy affirmed that the GPS distance affidavit, provided by the Blount County Sheriff's Office, confirmed that the distance from the proposed location to the nearest church, school, or place of public gathering exceeds 1,000 feet. There is one resident located within 300 feet of the establishment. Attorney Stuart asked if any members of the Board had questions for the applicant. Hearing none, Attorney Stuart asked if there were any questions from the members of the public. There were none. Attorney Stuart closed the public hearing, and advised the Chair that the application and supporting evidence met the legal criteria for the issuance of a beer permit. A motion was made by Commissioner Martin, seconded by Commissioner King, that the beer permit request be approved. An electronic vote was taken. The Chair declared the motion to have passed by the following vote:
