BE IT REMEMBERED, that the Blount County Education Committee met at Prospect Elementary School in Seymour, Tennessee, on Tuesday, December 3, 2024, at 12:30 p.m. Blount County Education Committee Chair Dawn Reagan called the meeting to order. There were 7 members present and 4 absent. The Chair declared that a quorum did exist. E. NEW BUSINESS.

1. School District Reports.

Director of Blount County Schools David Murrell thanked the attendees for their presence at Prospect Elementary School. He spoke highly of the school, their leadership, and introduced the school's Principal Heather Byrd. Dr. Byrd boasted about the facility, staff, students and community. She introduced a couple of third grade ambassadors, Gunner and Avery, who talked about their personal experiences at Prospect Elementary. Fifth grade teacher, Ms. Niethammer, was introduced and she spoke of her teaching experience at Prospect Elementary. Dr. Byrd and Ms. Niethammer mentioned different programs at the school, like WIN time (What I Need), and the support from the school board and commission.

Mr. Murrell mentioned celebrating the Level 5 schools, which is a growth indicator with 5 being the highest score; and the Reward schools, a designation by the state for growth and achievement. Those reward schools being Carpenters Elementary, Heritage High, Porter Elementary, and Samuel Everett.

Mr. Murrell introduced School Nutrition staff members Karen Helton and Idamae Wooten. Nutrition Services coordinates cafeteria staff and resources for all twenty-one schools in the Blount County School district. They oversee the planning, ordering, preparation and distribution of daily meals. Ms. Helton spoke about the school nutrition program being integral in providing students with the best nutritional foundation for learning. The program is funded by reimbursements from the USDA and school cafeteria sales. In 2023-24, the school district served a total of 849,000 lunches and 446,000 breakfasts. 52% of the school district receives free or reduced meals. The program not only follows strict USDA guidelines, but also federal, state and local regulations. School cafeteria equipment (e.g. ovens, dishwashers, etc.) is procured utilizing nutrition program funds, not tax dollars. Over the years, school nutrition has experienced a lot of mandated changes, even before COVID, and Karen and her staff are tasked with communicating and implementing the changes to remain in-compliance. Nutrition is very important for successful learning and through donations, food is also supplied to students for the weekends, extended breaks, even dinners.

Mr. Murrell mentioned a capital project for LED lighting at Heritage Middle. Supervisor of Facilities, Maintenance and Capital Projects James Duke briefly spoke about the district wide energy savings program that will increase lighting while reducing energy consumption.

There was no action taken.
