A RESOLUTION TO AMEND OTHER GENERAL GOVERNMENT SPECIAL REVENUE BUDGET

WHEREAS, Blount County requests to increase the Other General Government Special Revenue Budget (Fund 127) to appropriate American Rescue Plan Act of 2021 (ARPA) and Tennessee Department of Environment and Conservation (TDEC) funds for the completion of utility projects in Blount County, and

WHEREAS, a Special Call Meeting of the Blount County Commission was held on January 27, 2022 for the purpose of describing specific utility projects for South Blount, Knox Chapman, and Tuckaleechee utility districts as well as the City of Friendsville, and Town of Louisville for the use of ARPA and TDEC funds, and

WHEREAS, each of the proposed project descriptions are within the geographic boundaries of Blount County, and

WHEREAS, it is deemed to be in the best interest of Blount County, to amend the Other General Government Special Revenue Budget (Fund 127) as requested.

NOW THEREFORE, BE IT RESOLVED BY THE Board of Commissioners of Blount County, Tennessee assembled in regular session this 17th day of February, 2022 that the Other General Government Special Revenue Budget (Fund 127) shall be amended as follows:
