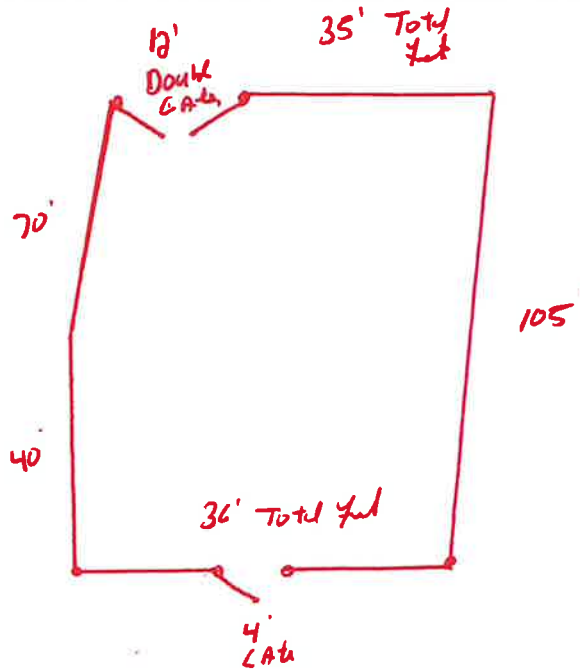

The fence is to follow the general contour of the ground and split the grade. The customer agrees to pay for extra labor or materials needed to properly complete erection. This extra labor includes digging in solid rock, filling or grading dirt, or clearing of fence lines.

The customer is responsible for determining property lines and the location of fence. The customer agrees to clear the right-of-way and remove any obstacles which will interfere with the fence erection.

The customer understands that the seller is not responsible for the location of or damage to any lines, pipes, cables or wires. Though reasonable care shall be taken by seller to avoid damage.

EAST TENNESSEE FENCE COMPANY agrees to warranty the fence against any defects in material or workmanship for a period of one year from date of completion.

If this agreement is canceled by the customer, the customer agrees to pay the seller any expenses already incurred. Any changes in materials or footage must be approved by seller. The customer agrees to pay a reasonable fee if an attorney is employed to enforce this agreement.
