#### Notice

- All quotations given, orders accepted, and all contracts entered into are subject to these Terms & Conditions.

### Prices / Price Ouotes:

- Price quotes for all products and services are firm for 30 days from the date of initial proposal.
- Price quotes do not include any sales use or excise taxes unless otherwise noted. Taxes will be added at the time of invoicing. Buyers who are exempt from taxes shall provide Envision Collaborative Interiors with copies of exemption certificates prior to order.

## **Deposit & Terms of Payment:**

- A 50% deposit will be required with all orders.
- The remaining 50% will be required upon receipt of furniture.

## **Order Changes & Cancellations:**

- Orders may not be charged or cancelled in whole or in part without prior written consent of Envision Collaborative Interiors. Changes may affect delivery times and rates.
- Products purchased are custom and made to order therefore cannot be returned.

### Installation & Redelivery / Rescheduling:

- Normal delivery and installation times are 9:00am to 5:00pm Monday to Friday. Delivery and installation performed after normal working hours and weekend will be at an additional charge. Additional charges may apply if elevator access is not provided for multi-story projects.
- When redelivery or rescheduling of products is required because the customer is unable to accept the merchandise, Envision Collaborative Interiors requires no less than 24 hours of notice prior to the scheduled delivery date. Envision Collaborative Interiors reserves the right to charge a fee to the customer for freight, re-handling, and warehouse merchandise.
- The customer agrees that the job site shall be clean, clear, and free of debris prior to installation. Electric current, Heat/AC, Hoisting, and/or elevator services shall be provided without charge to Envision Collaborative Interiors.
- Furnishings delivered and brought onto the job site as scheduled shall be inspected and conditionally accepted by the customer. The responsibility for the security and safeguarding of the delivered furnishings shall be at the time pass to the customer.
- A licensed electrician will need to be hired by the customer for building power connection for any furniture infeed power.

## Storage / Held Orders:

- If the customer requests a delay after the initial agreed upon delivery date, the customer must pay for the product in full and when the order is ready for shipment, Envision Collaborative Interiors may transfer the product to storage. All expenses incurred in connection with storage shall be payable by the customer.
