Hallways: Clean

Intake: General area – Housekeeping is good, Offices clean, Primary (officers) Bathroom, clean; both showers have new floor mats, which is a great resolve until showers can be upgraded. Entire shower area was clean.

Cell#1 – Empty, cell is clean all that is needed is the floor to be mopped. No noticeable maintenance issues noted. Cell #2 – Occupied (inmates just arriving and not dressed out yet). Cell is clean and not notable maintenance issues found. Cell #3 – Empty and not yet cleaned. Tissue paper wads and strips littering the floor, something brown has been splattered on one of the walls, commode needs cleaning. Lighting is good and no maintenance issues are noted. Cell #4 – Occupied, and has no noticeable issues of cleanliness or maintenance. Cell #5 – (Sallyport and pre-processing) the car wash area is clean, supplies organized and stored. No vehicles are being washed at the time of this visit. One arrestee has been brought in for processing. Cell #6 – is empty and has not yet been cleaned. No maintenance issues noted. Cell #7 – Supply Area for Car Wash Crew, is clean and organized and no maintenance issues are noted. Fingerprint area, stained ceiling tiles need to be replaced, no other issues noted. Cell#8 – Empty and has been cleaned. Floor drain needs in need of cleaning. No other maintenance issues noted. Cell #9 – Occupied and has no issues. Cell is clean and well lit. Cell #10 – has been converted into a virtual courtroom (not in use during this visit) needs a general cleaning. Cell #11 – Serves a dual purpose as Lawyer/Client Interview Room and virtual courtroom. It is not in use at the time of this visit and is clean.

*ONGOING ISSUES: None noted.

Medical: Exam # I – Not in use at the time of this visit. The floor is both dirty and sticky, counter and sink need to be cleaned. No maintenance issues noted. Exam # 2 – Is now used as a supply room and has trash on the floor, sink and counter need to be cleaned. No maintenance issues noted.

Pharmacy: Clean and orderly.

- M-2 This is the decontamination area; Area is clean.
- M-3 Occupied and clean. The floor, pie hole and door need to be cleaned both inside and outside.
- M-4 Occupied, and the cell is clean.
- M-5 Occupied, and is clean except the door and pie hole need to be cleaned. The new floor epoxy is coming off apparently from moving beds in and out.
- M-6 Occupied, and is clean. No maintenance issues noted.
- M-7 Occupied and clean. The floor tile is broken in several places and needs to be replaced as soon as can be arranged.

- M-8 This cell is occupied and is clean except the floor around the commode needs to be cleaned.
- M-9 Occupied, the cell is occupied and clean. No maintenance issues noted.
- M-10 Is occupied and in good condition. The light cover needs to be cleaned or replaced.

Hallway floors need to be cleaned and trash cans need to be emptied. The shower is not in use and is the walls need to be cleaned of soap scum. The nurse's main office is clean. Office used for dental hygiene is locked, did not inspect.

NOTES: **Medical continues to be cold and damp. Air circulation needs to be improved.

Kitchen: Food storage area – stands in need of additional shelving space. Cleaning was in progress. No issues noted during this visit and no complaints or needs were registered. *Exhaust hood over the stove needs to have the dry sprinkler system replaced.

Laundry: Clean- No laundry being done during this visit. Area is clean and organized and leaks have been repaired. The middle dryer is down for repairs, waiting for parts.

Library: Orderly (it is a shared space with equipment storage). Could use a dedicated space.

Dinner delivery was in progress.

Staff Offices: Clean and organized.

C-16 Stockroom: This is where Pod Workers change from work uniforms back into their stripes. Area is clean and organized.

Outside Recreation Yard: Drains appear to be open, there is no standing water issues.

Multipurpose Room: No in use at the time of this visit. The carpet needs to be vacuumed and tables need to be cleaned.

C-Pod Hallways: Clean, large trash cans will be emptied by nighttime pod workers. Dinner delivery in progress.*

NOTES:

The wall cracks in C-16 have no noticeable changes. The cracks appear worse in winter due to thermocycling.

The boilers were down for repairs and there was no hot water for several days. Parts came in, and the boilers have been repaired.

INMATE COMPLAINTS: Several complaints were registered regarding a lack of hot water, but as noted the problem has been repaired.

INMATE COMPLAINTS: No hot water. As noted in C Pod, the Boilers were down for several days, but have been repaired. Suggest that the maintenance department investigate the cost of keeping common repair/replacement parts in inventory so as to help alleviate the long lead time for parts.

Recreation Yard: Drains are open and the yard is clean. No maintenance issues noted.
