A RESOLUTION AUTHORIZING PURCHASING TO AUCTION SURPLUS VEHICLES AND ASSETS WITH A VALUE GREATER THAN ONE THOUSAND DOLLARS

WHEREAS, Blount County purchasing department requests permission for approval to auction county vehicles and surplus property valued at over one thousand dollars in accordance with the 1957 Act and T.C.A. 5-14-108; and,

WHEREAS, Tennessee Code Annotated 5-14-108(o) and adopted by the County Commission (Resolution No. 07-08-010) states that all sales of county owned property, real or personal in nature, that has become surplus, obsolete, or unusable shall be made available by public auction (including internet auction) or by sealed bid at the discretion of the purchasing agent; and,

WHEREAS, By law all vehicles must go through County Commission for approval before being put up for auction and require a separate motor vehicle disposition record; and,

NOW, THEREFORE, BE IT RESOLVED by the Legislative Body of Blount County, Tennessee, assembled in regular/called session on this 21st day of August 2025 that the following list of property be identified as surplus property and be approved to go to be sold at auction as follows:
