**A PROCLAMATION HONORING SCOTT KING FOR HIS DEDICATED SERVICE TO
THE CITIZENS OF BLOUNT COUNTY, TENNESSEE**

BE IT PROCLAIMED, by the Board of Commissioners of Blount County, Tennessee, in regular session assembled this ____ day of _____, 2026:

WHEREAS, Scott King began his tenure as the Blount County Commissioner for the Third (3) Commission District - Seat A after being nominated and appointed on September 12, 2017, and having been reelected by district citizens in 2018 and 2022, marking a total of nine years of dedicated public service to Blount County citizens; and

WHEREAS, while serving as Blount County Commissioner, Scott King has contributed generously and earnestly of his time, endeavoring to help the citizens in his district, as well as all citizens of Blount County, by giving support for the implementation of policies which have resulted in a more stable financial status, and the continuance of a low annual property tax rate, the approval of a partnership between Blount Memorial Hospital (BMH) and Prisma Health, passage of a resolution for a contingency plan to use local/state funds to keep the Great Smoky Mountains National Park operational during a federal government shutdown, establishing a coordinating committee for Blount County's celebration efforts to honor the 250th Anniversary of the Declaration of Independence, maintaining an outstanding animal control program, while giving support of many educational requests and projects, including several which were in his district; and

WHEREAS, during his term in office, Scott King has served on the Board of Commissioners, Commission Agenda/Workshop Committee, Beer Board, and Planning Commission; and

WHEREAS, Scott King, while serving as County Commissioner, has faithfully served and advocated for all Blount County taxpayers; and

WHEREAS, Blount County sincerely appreciates the many contributions given by Scott King in selfless service to the citizens of Blount County.
