A RESOLUTION NAMING THE EASTBOUND BRIDGE TOWARD TOWNSEND ON U.S. HIGHWAY 321 IN BLOUNT COUNTY, TENNESSEE, PFC CLAYTON E. NARVESON MEMORIAL BRIDGE

WHEREAS, Clayton Edward Narveson was born in Browns Valley, Minnesota, on January 27, 1924, the son of Nels and Ella Narveson, and raised in Austin, Minnesota. Clayton was a devoted son, brother, husband, father, grandfather, great-grandfather, comrade and friend. Clayton passed away just before his 99th birthday on January 20, 2023; and

WHEREAS, Clayton entered the USMC in December 1942, and completed his basic training at the Marine Corps Recruit Depot in San Diego, California. He served with both the Second and Fourth Marine Divisions during World War II as a gunner on an 81mm mortar. After embarking on the USS Harris (APA-2 for transportation, he participated in the Invasion of Tarawa in November 1943. On May 21, 1944, he was injured while on an LST in the West Loch disaster in Pearl Harbor, Hawaii. Later, he embarked on the USS Newberry (APA-158) for transportation to and participation in the Battle of Iwo Jima in February/March 1945. Clayton witnessed the American Flag being raised at Iwo Jima. Then in December 1945, Clayton received his Honorable Discharge as *Private First Class* from the Marine Corp; and

WHEREAS, Clayton, an Honorary Colonel in the State of Tennessee and active member of VFW Post 10855, being very involved with his church, the community, and speaking to school children and various organizations, should be memorialized for his selfless service and sacrifice to his Country and fellowmen; and

WHEREAS, it would be appropriate to request the State of Tennessee name *the eastbound bridge toward Townsend* in Blount County, Tennessee, on Highway US-321 over the Foothills Parkway *PFC Clayton E. Narveson Memorial Bridge*; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Blount County, Tennessee, in conjunction with Blount County Mayor Ed Mitchell, the Blount County Veterans Affairs Committee, and the United Veterans of Blount County, that:

1. *The eastbound bridge toward Townsend* on Highway US-321 over the Foothills Parkway in Blount County, Tennessee, be named *PFC Clayton E. Narveson Memorial Bridge*; and
2. A copy of this resolution be sent to the Blount County Legislative Delegation of the Tennessee General Assembly in Nashville, Tennessee, to show support for this request. (Exhibits attached hereto include a map of the bridge location, and the obituary including a picture of Clayton Edward Narveson.)

BE IT FURTHER RESOLVED that this resolution take effect from and after passage, the Public Welfare requiring it.

BE IT FURTHER RESOLVED that this resolution be made a part of the official records of the Board of Commissioners of Blount County, Tennessee.

BE IT FURTHER RESOLVED that this resolution replace and supersede Resolution No. 23-03-012 adopted by the Blount County Board of Commissioners assembled in regular session on March 21, 2023.
