### ROLL CALL

**BE IT REMEMBERED**, that the Blount County Education Committee met at Walland Elementary School in Walland, Tennessee, on Tuesday, September 30, 2025, at 12:30 p.m. Blount County Clerk Gaye Hasty called the meeting to order. There were 5 members present, with the late arrival of Robbie Bennett, and 4 were absent. The Clerk declared that a quorum did exist. In addition to the Education Committee members, others present were: Walland Elementary School Principal Jennifer Tipton; BCS Chief Finance Officer Brittany Spence; BCS Chief of Staff & Operations Courtney Whitehead; BCS Chief of Elementary Instruction April Heron; BCS Chief of Secondary Instruction Jon Young; and BCS Chief of Curriculum & Professional Development Dr. Heather Byrd; and BC School Board member Chris Pass. ### F. NEW BUSINESS.

#### 1. Report from Principal.

Principal Jennifer Tipton of Walland Elementary School was recognized. She highlighted the contributions of Instructional Coach, Paula King, and the implementation of the Instructional Practice Guide (IPG). The school's success rate increased to 33%, up from 24% the previous year. While they previously achieved a Level 5 in student growth, they maintained strong performance with a Level 4 in growth this year. Notably, the school saw a significant increase in overall achievement, with steady growth across all student groups, including English as a Second Language (ESL) students, students with disabilities, and those considered economically disadvantaged.

**2. School District Reports.**

The Chair recognized Director of Schools, Mr. Justin Ridge, who provided a list of capital improvements and other projects for the 2025-26 school year. He envisions the Education Committee's involvement in prioritizing future projects.

The Chair recognized School Board Members Mr. John Lowe and Mr. Chris Pass. It was noted that Erica Moore resigned from the Education Committee. To fill the vacancy, Randi Howard was nominated by the School Board.
