RESOLUTION TO APPROVE INTERLOCAL AGREEMENT BETWEEN
BLOUNT COUNTY, TENNESSEE AND THE CITY OF MARYVILLE, TENNESSEE
TO SECURE HPP (HIGH PRIORITY PROJECT) FEDERAL TRANSPORTATION FUNDS
FOR THE IMPROVEMENT OF MORGANTON ROAD

BE IT RESOLVED by the Board of Commissioners of Blount County, Tennessee, in special session assembled August 29, 2017.

WHEREAS, Blount County, Tennessee (hereinafter "Blount County") and the City of Maryville, Tennessee (hereinafter "Maryville") have jointly agreed that it would be beneficial to all parties and the citizens of this community to seek to secure HPP (High Priority Project) federal transportation funds for the improvement of Morganton Road between Foothills Mall Drive and William Blount Drive; and

WHEREAS, Morganton Road is a public road with part of the road located currently in Blount County outside of city limits and part of the road located within the corporate limits of Maryville; and

WHEREAS, the parties have agreed that Blount County, through its Highway Department, shall reasonably work towards securing the available HPP funds as soon as possible; and

WHEREAS, the parties have agreed that Blount County and Maryville will both be a party to any and all contracts relating to the project; and

WHEREAS, the parties have agreed to the estimated allocation of percentages of local contributions as shown on Exhibit A of the Interlocal Agreement (attached hereto as Exhibit 1); and

WHEREAS, it is in the best interest of Blount County to enter into and approve the Interlocal Agreement between Blount County and Maryville for the purposes securing federal transportation funds and improving Morganton Road between Foothills Mall Drive and William Blount Drive. Said Interlocal Agreement is attached hereto as Exhibit 1.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Blount County, Tennessee, that the Interlocal Agreement between Blount County, Tennessee and the City of Maryville, Tennessee, which is attached hereto as Exhibit 1 and incorporated herein by reference is approved and the Mayor is hereby authorized to execute the agreement on behalf of Blount County.

BE IT FURTHER RESOLVED THAT THIS RESOLUTION SHALL TAKE EFFECT FROM AND AFTER PASSAGE, THE PUBLIC WELFARE REQUIRING IT.

INTERLOCAL AGREEMENT

THIS INTERLOCAL AGREEMENT is made and entered into as of theday of
, 20, by and between THE CITY OF MARYVILLE, TENNESSEE ("Maryville"), a
municipal corporation located in Blount County, Tennessee; and BLOUNT COUNTY, TENNESSEE ("Blount
County"), a political subdivision of the State of Tennessee, as follows:
WITNESSETH:
THAT WHEREAS, Blount County seeks to secure HPP (High Priority Project) federal
transportation funds that have been made available for the improvement of Morganton Road between
Foothills Mall Drive and William Blount Drive; and
WHEREAS, Morganton Road is a public road with part of the road located currently in Blount
County outside any city limits and part of the road located within the corporate limits of the City of
Maryville; and
WHEREAS, Blount County and the City of Maryville desire to work together in a cooperative
manner to share the local cost burden to improve Morganton Road ("Project").
WHEREFORE, the parties hereto hereby agree as follows:
1. <u>Purpose</u> . The purpose of this Agreement is to establish the role of each participating party in the
construction of the proposed improvement of Morganton Road between Foothills Mall Drive
and William Blount Drive in Blount County, Tennessee.
2. Term. The term of this Agreement shall be from the date of this Agreement through the date
when the Project is complete.

a. <u>Blount County.</u> Blount County through its Highway Department agrees to reasonably work towards securing the available HPP funds as soon as possible for this Project. Blount County will be a party in any and all contracts relating to the Project and agrees to the allocation of percentages of local contributions as shown on Exhibit A hereto,

3. Responsibilities.

- which is an estimate of the cost of the Project. Blount County further agrees to make payments as needed for the Project as estimated on Exhibit A, if such funds are approved in its future budgets. Blount County agrees to timely request the appropriate funds for the Project from County Commission in each applicable budget.
- b. Maryville. Maryville agrees to be a party to any and all contracts relating to the Project as appropriate and agrees to the allocation of percentages of local contributions as shown on Exhibit A hereto, which is an estimate of the costs of the Project. Maryville further agrees to make the payments as needed for the Project as estimated on Exhibit A, if such funds are approved in its future budgets. Maryville agrees to timely request the appropriate funds for the Project from City Council in each applicable budget.
- 4. Maintenance and services remain in respective jurisdictions. This Agreement does not provide for routine maintenance or repair of asphalt pavement, signs, and/or pavement markings beyond jurisdictional boundaries. Blount County will continue to maintain and repair the sections of Morganton Road that are not within the corporate limits of the City of Maryville. Maryville will continue to maintain and repair all sections of the road that are presently in and/or become annexed into the corporate limits of the City of Maryville.
- Timing for completion. The parties agree to the timeframes set forth on Exhibit A as goals for the progress of the Project.
- 6. <u>Amendments</u>. This Agreement may be amended only in a writing signed by all parties hereto and authorized by the governing body of each party to this Agreement.
- 7. <u>Relationships</u>. The participants in work undertaken under this Agreement shall remain employees only of their own respective employers and neither the participants nor the parties shall be agents, representatives or joint venture partners of the other party hereto.

RESOLUTION TO AUTHORIZE BLOUNT COUNTY MAYOR AND BLOUNT COUNTY HIGHWAY SUPERINTENDENT TO APPLY FOR HPP (HIGH PRIORITY PROJECT) FEDERAL TRANSPORTATION FUNDS FOR THE IMPROVEMENT OF MORGANTON ROAD

BE IT RESOLVED by the Board of Commissioners of Blount County, Tennessee, in special session assembled August 29, 2017.

WHEREAS, Blount County, Tennessee (hereinafter "Blount County") and the City of Maryville, Tennessee (hereinafter "Maryville") have become aware that there are certain federal highway funds available that could be used for the improvement of Morganton Road between Foothills Mall Drive and William Blount Drive; and

WHEREAS, Blount County and Maryville have jointly agreed that it would be beneficial to all parties and the citizens of this community to seek to secure HPP (High Priority Project) Federal Transportation Funds for the improvement of the above-described section of Morganton Road; and

WHEREAS, Blount County and Maryville have entered into an Interlocal Agreement to work together on the above-described improvements to Morganton Road; and

WHEREAS, pursuant to the Interlocal Agreement, part of the responsibility of Blount County is to work toward securing the available HPP (High Priority Project) Federal Transportation Funds for said project; and

WHEREAS, it is necessary for Blount County to take certain actions by way of its Mayor and Highway Superintendent to seek and secure the funding for the subject project.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Blount County, Tennessee, that the Blount County Mayor and Blount County Highway Superintendent are hereby authorized to take such steps as is necessary to apply for and receive the funding provided by the federal government of the High Priority Project (HPP) Federal Transportation Funds for the improvement of Morganton Road between Foothills Mall Drive and William Blount Drive as described in the Interlocal Agreement entered into between the Blount County, Tennessee and the City of Maryville, Tennessee.
