

**RESOLUTION NO. 23-02-012**

**SPONSORED BY COMMISSIONERS Dyran Bledsoe AND Rick Carver**

**A RESOLUTION THAT APPROVES AN AGREEMENT WITH SHI-GOVERNMENT SOLUTIONS, INC. (“SHI”) FOR THE ASANA SOFTWARE SUBSCRIPTION WHICH EXTENDS BEYOND THE END OF THE FISCAL YEAR 2022-2023**

**WHEREAS**, the Board of Commissioners of Blount County, Tennessee, adopted the provisions of Tennessee Code Annotated, § 5-14-101 et. seq., known as the County Purchasing Law of 1957; and

**WHEREAS**, Tennessee Code Annotated §5-14-108(m)(1) states that the county purchasing agent is authorized to purchase and contract to purchase materials, supplies, equipment and contractual services on a fiscal year basis, but no commitment shall be made which extends beyond the end of the current fiscal year for which appropriations have been made by the county legislative body, except such commitments as are authorized by resolution of the county legislative body; and

**WHEREAS**, ASANA Software is a project management software which allows multiple departments and our vendor community to stay connected between our project goals, budget, changes in scope, etc. This will reduce time and promote effective communication that leads in to efficiency. It will allow the user department to have the right materials, and equipment, at the right time and place for our team to operate productively. The ASANA software can schedule a task, and provide a workflow and document storage that is project specific.

**WHEREAS**, the Purchasing Department requests a multi-year contract, on behalf of the IT Department, with SHI that will extend beyond the current fiscal year to maximize subscription cost saving.

**NOW THEREFORE, BE IT RESOLVED** by the Board of Commissioners of Blount County, Tennessee, assembled in regular session this \_\_\_\_\_ day of \_\_\_\_\_ 2023, that a multi-year contract with SHI-Government Solutions, Inc. be approved for Blount County, Tennessee, with the term extending beyond the current fiscal year.
