5th Judicial Drug Task Force

- Established as Blount Metro Narcotics in 1986
- Became a Judicial Task Force in 1988 under Governor McWherter's Drug Free TN
- Moved into the current location in 2005. The building was purchased with Drug Task Force funds.
- During this time period, the Drug Task Force received funding through the Office of Criminal Justice Programs in the form of the Byrne Grant.
- The Drug Task Force is no longer eligible for grant monies due to the fund balance being too high. The fund balance increased over the years to prepare for future growth.
- Currently, the Drug Task Force has grown to have (15) total employees; (1) from Alcoa PD, (2) from Maryville PD, and (12) from the Blount County Sheriff's Office. Of those (15) employees, (1) is assigned full time to the Drug Enforcement Administration and (1) is assigned full time to the Federal Bureau of Investigation.
- State and Federal agencies have assigned officers to work out of the current DTF. This
 includes the Tennessee Bureau of Investigation and the Alcohol, Tobacco, and Firearms
 (ATF). We also work closely with Homeland Security and the United States Marshals
 Service. This provides our local law enforcement with additional resources to serve our
 community at no cost to the citizens of Blount County.
