SPONSORED BY COMMISSIONERS MIKE LEWIS AND MIKE CAYLOR

A RESOLUTION TO APPOINT A JUDICIAL COMMISSIONER

WHEREAS, T.C.A. 40-1-111 provides for the appointment of judicial commissioners by the chief legislative body of a county; and

WHEREAS, T.C.A. 40-1-111 provides that the legislative body, in making decisions relative to retaining judicial commissioners, shall take into consideration the comments and suggestions of the judges of the courts in which the judicial commissioners are appointed to serve; and

WHEREAS, Blount County has historically used judicial commissioners inasmuch as judicial commissioners assist in the efficient administration of justice in Blount County, Tennessee; and

WHEREAS, T.C.A. 40-1-111 provides that the legislative body shall set the terms of the judicial commissioners with said terms not to exceed a term of four (4) years; and

WHEREAS, T.C.A. 40-1-111 further provides that the presiding general sessions criminal judge of a county may appoint part-time judicial commissioners at the discretion of the presiding judge; and

WHEREAS, Barbara Davis has recently resigned as a Judicial Commissioner for Blount County, she was serving in that capacity on a full time basis. Further, Darryl Monday has been serving as a part time Judicial Commissioner and should be appointed a full time Judicial Commissioner to take Ms. Davis' place; and

WHEREAS, the Judges of the Blount County General Sessions Court desire that the above-named individual be appointed by the legislative body for a four (4) year term, as provided by T.C.A. 40-1-111; and

WHEREAS, the compensation for said judicial commissioner is already in this year's current financial budget for Blount County, Tennessee.

NOW THEREFORE, BE IT RESOLVED as follows:

1. The following named individual is hereby appointed Judicial Commissioner for Blount County, Tennessee:
 - a. Darryl Monday
2. **DUTIES:** The duties of said judicial commissioner shall be as set forth and prescribed in T.C.A. 40-1-111.
3. **TERM OF OFFICE:** The term of office of the judicial commissioner appointed above shall expire on August 31, 2020 as provided by T.C.A. 40-1-111.

4. COMPENSATION: The compensation of the above judicial commissioner shall be as set forth in the Blount County, Tennessee fiscal budget for 2016/2017.

BE IT FURTHER RESOLVED THAT THIS RESOLUTION SHALL TAKE EFFECT IMMEDIATELY, THE PUBLIC WELFARE REQUIRING IT.
