Board Attorney Craig Garrett administered the oath to Brian Raymond, District Manager for Dollar General Store, and representative for Dolgencop, LLC. Mr. Raymond testified that the Corporation filed the beer permit application for an off premises consumption at the location; that the business he is seeking the permit for is Dollar General Store #17460, 3613 E. Lamar Alexander Parkway, Maryville, TN 37804, and that the information and statistics in the application are true and correct as far as he knows; that the distance of the nearest church is 2,166 feet (Pleasant Grove Baptist Church); that the distance to the nearest school is 4,714 feet (Heritage Middle School); and, that there was no one present at the hearing that has shown up to protest that is a resident that lives within the distance of 300 feet. Mr. Garrett asked if there were any questions from the Board. Mr. Garrett asked if there were any questions from the public regarding the application. There was no response.
