Mr. Toon testified that the answers and information that he was providing to the Board are true and correct to the best of his knowledge and belief; that he had applied on behalf of Dolgencorp, LLC, for an off premises beer permit at Dollar General Store at 3614 HWY 411 S., Maryville, TN. Mr. Toon testified that, pursuant to the survey, the closest church is 1,357 feet; the closest school is 7,998 feet, and the closest resident is 366 feet. Mr. Garrett asked if there were any questions from the Beer Board. There were none. Mr. Garrett stated there was no one there for public comment. Mr. Garrett recommended to the Board that the criteria was met for the issuance of the beer permit.
