NOTICE: A non-refundable \$250 fee must accompany this application. If the application is approved you are required to provide documentation of sales tax registration to the county within ten (10) days of approval. A survey provided by a registered Tennessee Surveyor or certified GPS measurements performed by the Blount County Sheriff's Department shall be included with this application with at least the following information: distance to the nearest incorporated city or town, distance to the nearest church (or other place of worship), distance to the nearest school, distance to the nearest place of public gathering.

A privilege tax of \$100 is imposed on the selling, distributing, storing or manufacturing beer in this state. The tax is due each January 1 and is payable to the Blount County Clerk. This tax is prorated for new permits issued after January 1, and must be paid when the permit is issued.

ANY APPLICANT MAKING ANY FALSE STATEMENT IN THIS APPLICATION SHALL FORFEIT HIS PERMIT AND SHALL NOT BE ELIGIBLE TO RECEIVE ANY PERMIT FOR A PERIOD OF TEN YEARS.

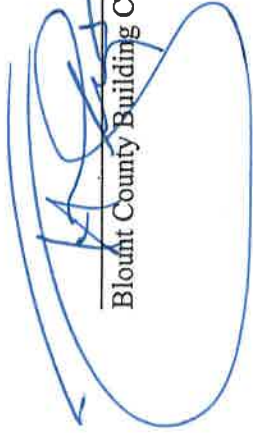

Our company has completed your request for the measurements required by Blount Co., Tennessee for your Application for Certificate of Compliance on the building at the address 1826 Morganton Road. Blount County requires that a proposed location must exceed 1000 feet measured from building to building of any church, school, or other places of public gathering. We found the nearest building to meet these requirements was that of the Fellowship Baptist Church at 1102 Big Springs Road and being 1480 feet at the closest point as shown on the attached exhibit. The County also requires that proposed location must exceed 300 feet as measured from building to building to any residence. 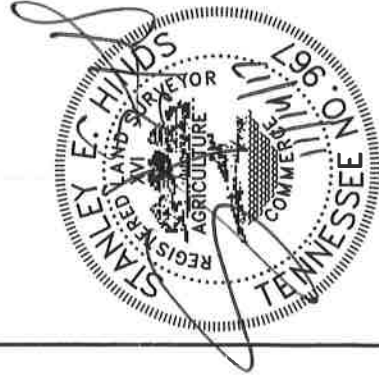
