**RESOLUTION OF THE COMMISSION OF BLOUNT COUNTY, TENNESSEE,  
APPROVING AN ADDENDUM TO THE AMBULANCE SERVICE AGREEMENT WITH  
AMR RURAL/METRO OF TENNESSEE, L.P. TO PROVIDE MEDICAL AMBULANCE  
SERVICES IN BLOUNT COUNTY FOR AN ADDITIONAL TWO (2) YEAR TERM  
(JULY 1, 2018 – JUNE 30, 2020) AS ALLOWED IN THE CURRENT CONTRACT,  
SUBJECT TO COUNTY COMMISSION APPROVAL**

WHEREAS, Blount County Government desires to contract for medical ambulance services in Blount County; and

WHEREAS, It has been determined that AMR Rural/Metro of Tennessee, L.P. has performed adequately, based on criteria set forth in the current contract to recommend a 2 (two) year extension of the current contract.

WHEREAS, the proposed extended ambulance service agreement with AMR Rural/Metro of Tennessee, L.P. is for an additional two (2) year term commencing at 00:00:01 hours on July 1, 2018 and terminating at 24:00 hours on June 30, 2020.

NOW THEREFORE BE IT RESOLVED BY THE BLOUNT COUNTY COMMISSION AS FOLLOWS:

The Ambulance Service Agreement with AMR Rural/Metro of Tennessee, L.P. to provide medical ambulance services in Blount County is hereby adopted and approved in substantive form as presented this date, a copy of which is attached to this Resolution and incorporated herein by reference.

BE IT FURTHER RESOLVED, the Ambulance Service Agreement with AMR Rural/Metro of Tennessee, L.P. to provide medical ambulance services in Blount County shall be executed subject to such amendment or action not affecting the substantive provisions of the contract as may be required and approved by the Purchasing Agent.

BE IT FURTHER RESOLVED, this Resolution is to take effect from and after its passage, as provided by the Blount County Commission, the public welfare requiring it.
