We are asking for permission to re-appropriate TDEC grant funds that were unused in FY 2018-19 for the Blount County Recycling Center on Levi Street.

This amount was appropriated last FY year by resolution with intention to spend in this FY 2019-20. However, my office failed to re-appropriate the amount into the new budget and the monies fell into fund balance.

If you remember, this grant will supply us with more oil storage capacity, diversify oil collection techniques and supplement our natural gas heaters in the maintenance shop by burning the collected used oil.
