Public Lobby: Excellent

Public Hallways: <u>Clean</u>

Intake: The common area is in good condition. Primary bathroom is clean except trash needs to be removed. Interview room is empty and clean. Evidence of previous water leak in the ceiling tile in hall leading to shower area. Showers: Showers are acceptable except the shower curtains need to be washed and floor cleaned. Cell #1 – Cell is empty and clean. It had just been painted and sanitized. Cell #2 – This cell is occupied by 12 dressed females waiting for housing, there were not enough mats or blankets for each inmate. The all of the floor space is used as sleeping space, also the ceiling air vent has tissue stuck to it. Cell #3 – Is occupied by 4 undressed females waiting for bond issue, the floor and commode looked clean. One inmate, Dockery complained of being cold and had no blanket. Cell #4 - This cell is occupied by 12 undressed (not yet in uniform) males that are being processed. This cell has some trash on the floor and tissue on the air vents. Cell #5 is the Garage/SALY Port area has been pressure washed and is clean. No cars are being washed at this time. Cell #6 – (Drunk Tank) This cell has 8 males occupying it and has trash on the floor. The commode also needs to be cleaned. Fingerprint Area – Floor is dirty, and ceiling tile show evidence of previous water leaks. Cell #7- is reserved for female car wash crew and supplies, it is fairly organized but could use some general housekeeping. Cell #8 has 2 females who are waiting for paperwork to be finished as they are being released. The cell has tissue paper on the ceiling vents but is otherwise clean. Cell #9 – Is empty, has tissue paper stuck to ceiling vents and needs to be cleaned and sanitized before placing persons in this cell. Cell #10 – This cell is occupied by 1 male and has tissue on the ceiling vents but is otherwise clean. The Interview room was in use for processing 3 inmates but appeared to be clean.

*The total number of inmates in Intake is 39 not including the 3 being processed at the time of this visit. Dockery was the only registered inmate complaint.

Medical:

Exam #1 – Clean but has a lot of equipment and boxes stacked in it.

Exam #2 – Clean

M-1 – Medical Supply Room – Clean and organized.

M-2 – *This is the low-pressure area and is not used for housing patients. Floor needs to be swept/mopped but is otherwise in good condition.

M-3 – Occupied by 1 male and is clean. Very cold in this area, this inmate has been Inmate Johnson complained that he has been in that cell without sentencing for several months. This particular cell is extremely cold.

^{*}Administrative Office Area: Clean and orderly, except water stained ceiling tile in all offices

- M-4 Occupied by 1 female and is clean except for tissue on light cover . Inmate Melissa Matsey complained of back pain without medication. Concrete floor has rough spots and needs to be repaired and painted.
- M-5 Occupied by 1 male who is also on suicide watch. The cell is clean except the floor needs to be swept and mopped. The concrete floor has some rough spots. It will need to be sanded or a grinder used to smooth out the rough places and patch with new epoxy flooring.
- M-6 Occupied by 2 females and has no noted issues.
- M-7 Occupied by 2 females and housekeeping is good. The vinyl baseboard is broken/torn off in places.
- M-8 Occupied by 4 males and has trash on the floor. It also needs to be mopped.
- M-9 Occupied by 6 males one of whom has fractured vertebrae in his neck. Another Inmate, Brad Hopper is in a back brace and complained that it is difficult from him to get up from his mat which is on the floor. This cell has tissue paper stuck to air vents and light covers, faucets on the sink are missing. A new sink is scheduled to be installed.
- M-10 Occupied by 5 females, floor needs to be cleaned, light fixture covers also have tissue paper on one of them.
- M-11 Case Management worker's office locked.
- M-12 Office for the Medical Nurse/Supervisor and Psych Nurse is clean.
- M-17 Dental Office locked.
- M-18 Laboratory Locked

Shower – Clean

Halls- *Cleaning and trash removal occurs during the night shift by pod workers. Floors need to be mopped and sanitized.

There are 22 inmates housed in medical at the time of this visit and inmate complaints are noted above.

Kitchen: Clean-up is in progress. The garbage disposer (aerator) out of order at the sinks in the pot wash area and one faucet is leaking on the hot water side.

Laundry: Area is clean, and laundry was in progress.

Property Room: Mold/Mildew noted on pipe insulation in the ceiling. Room very organized and neat.

C-Pod: *West wall in C-5 has very wide cracks and is separated from the ceiling. *C-6 has the same type of deterioration as C-5. Water comes in at the foundation in C block and around some windows during heavy rain events.
