The Blount County Recovery Court is a recipient of the Drug Court Discretionary Grant Program for Tennessee Veterans' Treatment Court Initiative. This was a 3 year grant originally awarded in 2017. The fiscal year for this grant is October 1 – September 30. The Blount County Fiscal year 18-19 ended June 30, 2019 leaving 3 months of year 2 on this grant.
