The Blount County Recovery Court is a recipient of a one-time Direct Appropriation Grant from the Department of Mental Health and Substance Abuse Services for the fiscal year of July 1, 2019 – June 30, 2020 in the amount of \$37,000. Please find attached the Resolution to Amend the Veterans' Treatment Court budget and the appropriation of funds.

The Letter of Agreement for this Grant specifies in item 1. (c) "The funds received shall be placed in an interest bearing account until such time as they are needed for the purposes set out in the Appropriations Act. In the event that any portion of the funds is not expended, the unexpended portion plus any accrued interest shall be return to the State."

The funds are being allocated for training of Veterans' Treatment Court staff, travel required to attend such trainings, travel to transport VTC participants as required, supplies for treatment curriculum, office supplies, drug screening of VTC participants and other specific needs that arise for VTC participants.
