WHEREAS, the Blount County Community Action Agency currently leases property from Blount County, Tennessee, a school building known as Hubbard Elementary School located at 3509 Tuckaleechee Pike, Maryville, Tennessee, 37803; and

WHEREAS, the lease agreement will expire after June 30, 2020; and

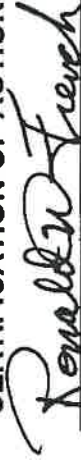
WHEREAS, it is in the best interest of both Blount County, Tennessee, and the Blount County Community Action Agency to enter into another lease agreement for said premises.
