**A RESOLUTION THAT APPROVES BLOUNT COUNTY, TN HUMAN RESOURCES DEPARTMENT AGREEMENTS THAT EXTEND BEYOND THE END OF THE FISCAL YEAR TERM.**

WHEREAS, the Board of Commissioners of Blount County, Tennessee, adopted the provisions of Tennessee Code Annotated, § 5-14-101 et. seq., known as the County Purchasing Law of 1957; and

WHEREAS, Tennessee Code Annotated §5-14-108(m)(1) states that the county purchasing agent is authorized to purchase and contract to purchase materials, supplies, equipment and contractual services on a fiscal year basis, but no commitment shall be made which extends beyond the end of the current fiscal year for which appropriations have been made by the county legislative body, except such commitments as are authorized by resolution of the county legislative body; and

WHEREAS, to better align with Blount County's calendar year benefits term, the Blount County Human Resources Department proposes the terms of the agreements with the following suppliers extend beyond the current fiscal year.
