Board Attorney Craig Garrett administered the oath to Mr. Shamshuddin Jamani, representative of Brickmill Market, LLC. Mr. Jamani testified that he is one of the owners of the LLC that has filed the beer permit application for an off premises beer permit consumption at the location; that the business he is seeking the permit for is Brickmill Market, 103 Brickmill Road, Maryville, TN 37801, and that the information and statistics in the application are true and correct to the best of his knowledge; that the distance of the nearest church is 1,234 feet (Bakers Creek Presbyterian Church); that the distance to the nearest school is 13,992 feet (Lanier Elementary School); and, that there is a residence within the 300 feet distance (251 feet,) but this is a grandfathered location. Mr. Garrett asked if there were any questions from the Board. Mr. Garrett asked if there were any questions from the public regarding the application. There was no response. Mr. Garrett closed the public hearing and recommended to the Board that the applicant meets the criteria for the issuance of the beer permit.
