Upon reviewing the duties of the Beer Board with the members, Board Attorney Craig Garrett administered the oath to Mr. Nick Dibartolomeo. Mr. Dibartolomeo testified that the answers and information that he was providing to the Board to be true and correct to the best of his knowledge and belief; that he had applied on behalf of Blackberry Farm, LLC, d.b.a. Blackberry Mountain, a restaurant, for an on premises beer permit at 121 Mountain Lodge Road, Walland, TN 37886. Mr. Dibartolomeo testified that, the area is actually East Millers Cove Road, not west; and pursuant to the survey provided with the application that it meets the distance requirements for a beer permit (the closest church or public gathering place being 9,800 feet, the closest school being 3 miles, and the closest resident being 2,900 feet). Marblegate Farm, an event venue, for an on premises beer permit at 308 McReynolds Road, Friendsville, TN 37737. Mr. Cobble testified that, the place of business is just outside the city limits and is in Blount County; and pursuant to the statistics provided with the application that it meets the distance requirements for a beer permit (the closest church or public gathering place being 7,332 feet, the closest school being 7,899 feet, and the closest resident being 2,014 feet). Board Attorney Craig Garrett administered the oath to Mr. Paresh Soni, the manager of the location. Mr. Soni testified that the answers and information that he was providing to the Board to be true and correct to the best of his knowledge and belief; that the application that was filed on behalf of Morganton Properties, LLC, for lan's Market #57, a convenience store, is for an off premises beer permit at 1620 Morganton Road, Maryville, TN 37801. Mr. Soni testified that the statistics provided with the application to be true and correct that the closest church or public gathering place being 1,018 feet, the closest school being 6,700 feet, however, the nearest resident is 212 feet, and a funeral home that could be considered a place of public gathering is 270 feet. Mr. Garrett stated that although the distance to nearest resident is under the 300 feet requirement, there is an existing permit holder at that location, and therefore, according to state law is deemed grandfathered in as relates to distance requirements. Mr. Garrett asked if any member of the Beer Board had any questions or comment. There was none. Mr. Garrett asked if there was any public comment. There was none. Mr. Garrett advised the Board that the applicant meets the criteria as set forth by the statute and is considered to be grandafthered in and the public hearing closed.
